

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.novastargaming.gg](http://www.novastargaming.gg) and Brimstar Gaming LLC DBA Novastar Gaming and governs data collection and usage. ## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Novastar may collect personally identifiable information, such as your:
